
Video Export Log File Release Notes

Video Export Log File

By default, the video file and a log file will be saved on your Desktop.

The video filename is saved as <CameraName> - <Capture Resolution> - <Capture FPS> - <Capture Format>_YYYYMMDD_HHMMSS with the .avi or .aira extension. The date and time reflects the start of the recorded clip.

• The video log file is named in the same manner as the video file but with a .txt extension. The exported video file contains an MD5 checksum (a digital signature). It is used to verify that the video file has not been altered.



 To verify the checksum, you must run md5sum against the video file and verify that the number matches the value in the log file. See the Aimetis Knowledge Base for instructions: http://www.aimetis.com/Support/kbarticle.aspx?ID=10086

• Files are created by default in approximately 640 MB segments. From the **Split Files at** drop-down list in the **Export Video** dialog box, you can now select file size segment: 10, 100, 640, 700, or 2000 MB. You can also enter any value in the field between 2 and 2000 MB.

• Consecutive files have a timestamp that represents the start of that file.




Figure 1. New Split Files at Option in Export Video dialog box

I/O Devices on Maps ADAM, Phoenix, and Axis Camera I/O

The **Edit Maps** dialog box contains a **Devices** tab listing all cameras and digital input and output devices. Along with ADAM devices, you can now use Phoenix, and Axis Camera I/O devices.




Figure 2. Digital I/O on map displayed with arrow icons




Figure 3. Adding an Axis Camera with Digital I/O invokes a Digital I/O tab in the Server Configuration dialog box




Figure 4. Digital I/O tab for Axis Cameras in Server Configuration dialog box

Display 4 Historical Video Streams Concurrently in Fast Forward Mode

You can play 4 historical synchronized video streams in Fast Forward mode or Reverse mode at 16 times real speed concurrently using the **Lock times on navigation** feature.




Figure 5. Four panels - Lock on time navigation enabled




Figure 6. All 4 videos in Fast Forward mode "No footage found message" displayed in panel of camera with no recorded video for a particular time

If some cameras do not have video for the start time the user has specified, one or more panels may display video for 1 second from a future time while the panels synchronize.

When Single Sign-On (SSO) is Enabled

SSO is transparent to the user; there are no specific messages associated with it. When registering to a new farm or editing an existing farm having **Windows Authentication** selected, the following message is displayed in case of failure: **Windows Authentication Failed. You must enter the user and the password.**

SSO works alongside the current/existing Symphony authentication process. Windows authentication is more secure than Symphony authentication; it makes use of the built-in Windows security system. Communication between client and server is made through a WSE 3.0 SOAP Web Service.



Important: If users need their registered farms available on any machine on the domain, they must enable roaming user profile (Windows).

Process Flow

- 1. When Symphony Client connects to a farm, it creates a security token, based on the identity of the currently logged-in Windows user; the user MUST have logged-in on the domain account.
- 2. The security token is sent to the farm/server for authentication.
- 3. Farm/server verifies that the token is valid and determines the domain account associated with it.
- 4. Upon success, farm/server sends a session ID back to the client.
- 5. On failure, the client's farm state changes to **Unauthorized**.
- 6. In case of failure, the user can login using Symphony credentials:
 - a. In Symphony Client, right-click your farm in **Server List**.
 - b. Select Edit. The Server Login Information dialog box opens.
 - c. Disable single sign-on: clear the **Windows Authentication** check box.
 - d. Click OK.
 - e. Enter user name and password.



Important: Multiple Symphony Clients on a single Windows login (each registered with a different user) are needed to run **Live Ban**. As such, **Single Sign On** will not be available for **Video Walls** when also running **Live Ban**.

Prerequisites

The Single Sign On feature uses the client's domain identity to authenticate to the server; therefore, the client and the server must be in the same security realm. As such, the Single Sign On feature is available only when:

- Client and server machines are logged on to the same domain, and
- The user logs on to the client machine as a *domain user* by using the domain credentials. (A user can log on to a machine *locally* in which case the Single Sign On feature is not available.)

On domains controlled by Windows Server 2008 (or later) and clients running Vista/Windows 7:

AES256_HMAC_SHA1 encryption must be disabled because it cannot be handled by the WSE 3.0
used by Single Sign On. This policy must be enforced by the domain controller and must be set by
the IT personnel in charge of the domain.

Task 1: In Symphony Client (or manually) enable single-sign on

Procedure

To enable or disable single sign-on in Symphony Client:

- 1. In Symphony Client, right-click your farm in the Server List.
- 2. Select Edit. The Server Login Information dialog box opens.
 - To enable single sign-on, select the **Windows Authentication** check box.
 - To disable single sign-on, clear the **Windows Authentication** check box.
- 3. Click OK.




Figure 7. Windows Authentication check box

Task 2: In Symphony Client, change the storage path for the farm registration to a network server

Procedure

To ensure that farm registration information is stored on a network server:

- 1. From the View menu, select **Settings**. The **Symphony Client Settings** dialog box opens.
- 2. Click the Global tab.




Figure 8. Global tab in the Symphony Client Settings dialog box

- 3. Select the **Custom path to farm registration** check box.
- 4. In the next field enter the path on the network where the registration information will be stored for all roaming users.
 - The network server storing all the farm registrations must be accessible from all Clients.
 - This is a global setting. All users that login to this Client will use this setting. Use the %WINUSER% variable when configuring this path so that each user has a unique path where the farm registration is stored. The user must have Windows "modify" rights to this folder. This is set only once on each Client machine.



Important: It is a security risk to have multiple users share a farm registration.




Figure 9. Changing where farm registration information is stored




Figure 10. HardwareDevice tab - I/O for Phoenix Devices




Figure 11. Phoenix I/O displayed in Camera Tree dialog box

Map Links

A list of all maps is displayed in the new **Map Links** tab. You select a map that will open when the user clicks on a hot link (box) in the primary map. You drag the map name onto the primary map. The resulting box, which can be almost any size and color, is the link.




Figure 12. Map Links tab in Edit Maps dialog box




Figure 13. Change opacity and color of the link

By default, the Render Mode for the Client display is now Video Mixing Renderer 9, custom presenter.

- Less memory impact than the VMR9
- Allows more than 16 panels to be viewed when 12 monitors are attached to ATI video card




Figure 14. Symphony Client Settings dialog box, Video tab Render Mode section

Export Video Release Notes

Export Video

Exporting video is now much easier. The **Save Clip** button and dialog box has been replaced with the **Export** button and **Export Video** dialog box.

- You can save the video in Symphony Video (.aira) format or in AVI format.
- The filename is saved as <CameraName> <Capture Resolution> <Capture FPS> <Capture Format> YYYYMMDD HHMMSS.
- The date and time reflects the start of the recorded clip.
- The **Symphony Video (.aira)** files are created in approximately 2GB segments, with the last file being less than 2GB. Consecutive files have a timestamp that represents the start of that file.
- For **AVI** (.avi) files are created in the size associated with the **Video Codec** you have selected. These can be very large files and they are NOT segmented. When exporting large amounts of video using AVI, the file can be over 2GB. After the export is completed, the file cannot be played in Windows Media Player.




Figure 15. Export Video dialog box with Symphony Video (.aira) format selected




Figure 16. Export Video dialog box with AVI format selected




Figure 17. I/O Devices with status displayed

Show/Hide Digital I/O in Device Tree

In the **Device Tree Configuration** dialog box, you now have the option of showing or hiding digital I/O devices. This is useful when the Device Tree lists numerous devices.




Figure 18. Device Tree Configuration dialog box with Options




Figure 19. Digital I/O displayed after Show Digital I/O option selected





Figure 20. Line tab - extending and shaping the counting line

- To extend the line: Click on the background image to create a new line segment from the existing line to the point clicked.
- To delete a segment: Click the **Delete Segment** button, which removes the last segment. **Delete Segment** will not remove the last (original) line segment to ensure there is at least one line segment for the report.
- To reshape the line: Hover the mouse over the box segment end-point: the cursor changes to a hand. Click and drag. The cursor changes to the move shape icon (arrows) and allows you to drag the vertex.

You can now select the format and recipient list of a report in the **Distribution** tab the **Report Designer**. Formats include: PDF, CSV (comma separated document), and XML.






Figure 21. Distribution tab

VE150 Versus VE180 BETA- Which analytic should you select?

VE150

- Consumes less CPU
- Best with mixed object types (for example, cars and people)
- Best with sparse objects (where overlap is rare)
- Calibration (tuning) is less important

VE180

- We recommend that you select the VE180 BETA only in a non-production environment
- Requires tracking region to contain only people
- Best with dense environments (people standing close together)
- Best for maintaining tracks of individual people entire person must be visible (not partially occluded by a table, for example)
- With correct settings, better able to deal with challenging environments (weather, lighting, etc)




Figure 22. Virtual cube does NOT fit scene




Figure 23. Virtual cube fits correctly in scene

- Depends strictly on the flat ground plain assumption. See Figure 22 on page 25: the scene is angled; the horizon is not aligned with the horizontal and vertical axes. Compare with Figure 23 on page 26 where the horizon is aligned with the horizontal and vertical axes.)




Figure 24. PTZ Calibration dialog box




Figure 25. Right-click on PTZ Camera in Camera Tree
